HOW TO USE THIS FORM:

Review the information you provide on this form carefully. This Statement of Water User's Claim form is required to assert your water right claim in the pending general adjudication. Under Utah law, unless you file a written Statement of Water User's Claim within 90 days of receiving notice, your water rights will not be recognized and you cannot assert them further. This form constitutes notice to you that your signed Statement of Water User's Claim must be filed within 90 days after service of this notice to you. Your Statement of Water User's Claim must be filed with the Division of Water Rights or the District Court. If you file your Statement of Water User's Claim with the Division of Water Rights, the State Engineer will file it with the District Court following the publication of the Proposed Determination. Signing and returning this form will not update ownership with the Division of Water Rights. If title to a water right needs to be updated, you must prepare and file a separate Report of Water Right Conveyance with the State Engineer.
