**NOTICE TO WATER USERS  
 A PROCLAMATION**

WHEREAS Henry H. Blood, Governor of the State of Utah, did on the 9th day of November, 1938, issue a Proclamation withdrawing from appropriation the surplus or unappropriated waters of the sources described in full below:

AND WHEREAS I, Herbert B. Maw, Governor of the State of Utah, did on the 19th day of April, 1948, upon the recommendation of the State Engineer, and pursuant to the authority vested in me by Section 100-8-2 Utah Code Annotated 1943, restore to public appropriation waters from wells, tunnels and drains for domestic and stock-watering purposes and for uses incidental thereto in the sources described in full below;

AND WHEREAS the State Engineer of the State of Utah has recommended that the surplus or unappropriated waters of the sources described in full below be restored by proclamation of the Governor pursuant to the authority vested in him by Section 100-8-2 Utah Code Annotated 1943;

NOW, THEREFORE, I, Herbert B. Maw, Governor of the State of Utah, upon the recommendation of the State Engineer, and pursuant to and by virtue of the authority vested in me by Section 100-8-2 Utah Code Annotated 1943, do hereby restore for all purposes to public appropriation waters from the following described sources:

The following tributaries to the Green River or tributaries thereto located in Summit County, Utah, and flowing into the Green River on or above the confluence of Sheep Creek and Green River; Big Muddy Creek, West Fork of Blacks Fork, Blacks Fork, Middle Fork Blacks Fork, East Fork Blacks Fork, Green River of Henry's Fork (Henry's Fork of Green River), Archie Creek, West Fork of Smith's Fork, Gilbert Creek to Smith's Fork, East Fork of Smith's Fork West Fork of Henry's Fork, Henry's Fork, Lost Creek, Spring Creek, Poison Creek, West Fork Beaver Creek, Middle Fork Beaver Creek, Burntfork, and tributaries thereto, immediate and remote;

The following tributaries to Green River or tributaries thereto, located in Daggett County, Utah, and flowing into Green River at or above Carter Creek:

Birch Creek, Birch Spring Draw, Sheep Creek, Carter Creek and tributaries thereto, immediate and remote.

This Proclamation to become effective after notice thereof has been published at least once a week for three successive weeks in a newspaper of general circulation within the boundaries of the river system or water sources heretofore described as provided in Section 100-8-2 Utah Code Annotated 1943.
