#### Other Comments:

This appropriation is for a fixed time, non-consumptive use of water for the extraction of lithium in an agreement with Forestry Fire and State Lands.

Once diverted, the water will be returned to the Great Salt Lake at a location to be determined so as to avoid commingling lithium rich brines with water exiting the facility without lithium.

This appropriation identifies several points of diversion as well as proposed places of beneficial use. Once the exact location is determined by the applicant, only one place of use and point of diversion will be retained and all other places of use and points of diversion will be abandoned.

This application is consistent with Gubernatorial Proclamation 2022-01, as issued by Governor Cox on November 3, 2022, as this application calls for a fixed time, non-consumptive use of water within the Great Salt Lake Basin. Although no water will be consumed by this fixed time application, the applicant intends to file a separate change application whereby applicants will deliver additional mitigation water to the Great Salt Lake as part of its desire to contribute to the enhancement of the Great Salt Lake.
