BRCC: These Applications could impact the GSL as a whole and conflict with efforts to protect the 1969 public willow

Friends: 13-4105-4110 - disagree w/ proclamation.

13-4105-4106 - are excluded if they are non-consumptive. The other rights should be denied as they are not allowed under the governor's proclamation.
