The List of Unclaimed Rights of Record is on file with the Clerk of the Third Judicial District Court in and for Salt Lake County located at 450 State Street, Salt Lake City, Utah. Additional copies may be obtained, upon payment of the cost of duplication, from the Division of Water Rights at 1594 West North Temple, Salt Lake City, Utah.

Any claimant who desires to object to the List of Unclaimed Rights of Record must file a written objection and a water user's claim with the Clerk of the Third Judicial District Court in and for Salt Lake County (pursuant to Utah Code § 73-4-9.5). A water user's claim must also be concurrently filed with the State Engineer. Objections to the List of Unclaimed Rights of Record must be filed within **ninety (90) days** of the date of this notice.

In accordance with Utah Code § 73-4-9.5 and § 52-4-207, the State Engineer will be holding a public meeting on August 15, 2023 at Wasatch County Senior Center (multi-purpose room), 465 East 1200 South, Heber City, Utah, 84032, from 6:00 p.m. to 7:00 p.m. to discuss the List of Unclaimed Rights and review the adjudication process. The public meeting will be viewable via live stream broadcast on-line at:
