
What is the best application for your needs?

  - Is the project going to require more than a small amount of water?

# **Consultation Meeting**

Utah Code § 73-3-3(2) A person filing an application may request consultation with the State Engineer or Regional Engineer

Nothing discussed in a consultation meeting becomes record, if the meeting is done in person, over the phone, or virtually

If documents are submitted to our office they become of record



### **Records Review**

#### Make sure the data shown on the database is accurate

Warning: Water Rights makes NO claims as to the accuracy of this data.



## Make the Process Smooth

Utah Code § 73-3-6 The State Engineer shall publish a notice of the application once a week for a period of two successive weeks in a newspaper of general circulation in the county which the source of supply is located and where the water is to be used (14 days).

Protest period is 20 days after advertising is complete.



That's 34 days!

Uncontested applications our goal is 80 days

### Change Application Tracker Percent Complete

Change Filed 0%	70% Hearing has been held
5% Approved for advertising	80% Regional office designated application for approval/rejection
6% Out of protest, no proof of publication	85% Application is in central review <b>100% Application</b> <b>is complete</b>
10% Proof of publication and contested, or application has been deferred	90% Central review complete, OSE being processed for final review
50% Proof of publication and uncontested or contested application with hearing scheduled

# So Your Application Was Protested


- Respond to protests, we may avoid a hearing if all issues raised by the protestant are addressed quickly by the applicant
- Utah Admin. Code R655-6-7 states a hearing shall be held if it is permitted by rule and requested by a party





# Respond to the Protest


- Address the items of concern brought up by the protestant
- Focus on items the State Engineer can address
- Provide evidence for a reason to believe





# Oh Great Now There's a Hearing

- Focus on items that the State Engineer can address
- Stay calm
- Be brief and to the point
- Hearings are informal

- Depending on your application we can discuss general ideas but not specifics of an application if all parties are not present
