This is the List of Unclaimed Rights of Record for the Salt Lake County East Division, Oakland Place Subdivision, Area N and Jordan River General Adjudication. The Division of Water Rights has prepared this List of Unclaimed Rights as required by U Unclaimed Rights lists each water right of record in the State Engineer's office for which a statement of claim was not timely filed. A Rights has been filed with the Clerk of the Third District Court in Salt Lake City, Utah. Printed copies are available, upon payment of printing costs, from the Division of Water Rights at 1594 W. North Temple, Suite 220, Salt Lake City, Utah, telephore, (881) 538-7248. An electronic copy in PDF is also available for download free of charge from the website of the Division of Water Rights at www.waterrights.utah gov.

You are hereby notified that under Utah Code § 73-4-9.5(2), any person claiming a water right in the Oakland Place Subdivision who is dissatisfied with the List of Unclaimed Rights may object to it in accordance with the requirements set by statute. The subject of an objection to the List of Unclaimed Rights is limited to inclusion of a water right in the List. To object, the claimant must file both a written objection and a statement of claim in the Third Judicial District Court, 450 South State Street, P.O. Box 1860, Salt Lake City, Utah 84114, within ninety (90) days after being served with notice of completion of the List of Unclaimed Rights. Service is effective on the date the notice is mailed (or hand delivered) to the claimant or is published. The claimant must also file a statement of claim with, and should send a copy of the objection to, the State Engineer by sending them to counsel for the State Engineer at the address shown below.

IN THE MATTER OF THE GENERAL DETERMINATION OF THE RIGHTS TO THE USE OF ALL OF THE WATER, BOTH SURFACE AND UNDERGROUND, WITHIN THE DRAINAGE AREA OF UTAH LAKE AND JORDAN RIVER IN UTAH, SALT LAKE, DAVIS, SUMMIT, WASATCH, SANPETE, AND JUAB COUNTIES IN UTAH LIST OF UNCLAIMED RIGHTS IN THE UTAH LAKE AND JORDAN RIVER GENERAL ADJUDICATION SALT LAKE COUNTY EAST DIVISION OAKLAND PLACE SUBDIVISION AREA NO. 57, BOOK 12

Kent L. Jones, P.E., State Engineer of the State of Utah, respectfully submits this List of Unclaimed Rights to the Court.

- 1. Geographical Area Covered. This General Adjudication, known as the Utah Lake and Jordan River General Adjudication, includes all water sources, both surface and underground, within the drainage of the Utah Lake and Jordan River in Utah, Salt Lake, Davis, Summit, Wasatch, Sanpete, and Juab Counties in Utah. This List of Unclaimed Rights is limited to water rights with points of diversion in the Oakland Place Subdivision of the Salt Lake County East Division of the Utah Lake and Jordan River General Adjudication. The Oakland Place Subdivision is the enlarged area on the map shown on page v. The Utah Division of Water Rights has designated the subdivision for this area as Area 57, Book 12 (or 57-12).
- 2. Commencement. On September 1, 1944, the Court ordered the State Engineer to make a determination and adjudication of all rights to the use of water of Utah Lake and Jordan River and their tributaries in Utah and Salt Lake Counties. On June 21, 1972, the Court issued an order clarifying that the adjudication area includes


all the rights to the use of water, both surface and underground, within the drainage area of Utah Lake and Jordan River and their tributaries in Utah, Salt Lake, Davis, Summit, Wasatch, Sanpete, and Juab Counties. The June 21, 1972 order also ordered that the title of this action be amended to read, "In the Matter of the General Determination of the Rights to the Use of all of the Water, Both Surface and Underground, Within the Drainage Area of Utah Lake and Jordan River in Utah, Salt Lake, Davis, Summit, Wasatch, Sanpete and Juab Counties in Utah."

3. State Engineer's Activity. The State Engineer has followed the requirements of Title 73, Chapter 4 of the Utah Code. He has given the required notices, served and published summons, completed hydrographic surveys, and taken claims from water users within the area. The State Engineer has searched the files of the Division of Water Rights prior to making the recommendations in the List of Unclaimed Rights. To the best knowledge of the State Engineer, this List of Unclaimed Rights contains all rights of record for which a Statement of Water User's Claim was not timely filed.





Oakland Place List of Unclaimed Rights Location Map






Foothill Village List of Unclaimed Rights Location Map







Anticipated Timeline (Oakland Place & Foothill Village)

March 23, 2018:

- State Engineer publishes the List of Unclaimed Rights.
- 90-day objection period begins.
- State Engineer holds a public meeting (April 03, 2018).

June 20, 2018:

90-day objection period for List of Unclaimed Rights ends.

November 2018:

- State Engineer publishes the Proposed Determination.
- 90-day objection period begins.
- State Engineer holds a public meeting.

February 2019:

90-day objection period for Proposed Determination ends.
